As evidence of the savings it can offer, Esker points to a new commissioned Total Economic Impact[™] study conducted by Forrester Consulting on behalf of Esker. The study examines Esker DeliveryWare deployment by a \$20 billion multinational manufacturer to integrate automated sales order processing with the company's SAP solution. It found that the implementation achieved annual labor cost savings of \$5 million over three years in addition to cost savings as a result of consuming less paper and reducing off-site document storage. Recent results achieved by SAP customers using Esker solutions also include:

- Century Furniture LLC — reduced paper costs by 99% and eliminated manual archiving
- Kimball International — supported 20% growth with no increase in staff
- Visy Industries — reduced late payments by a minimum of 5 days
