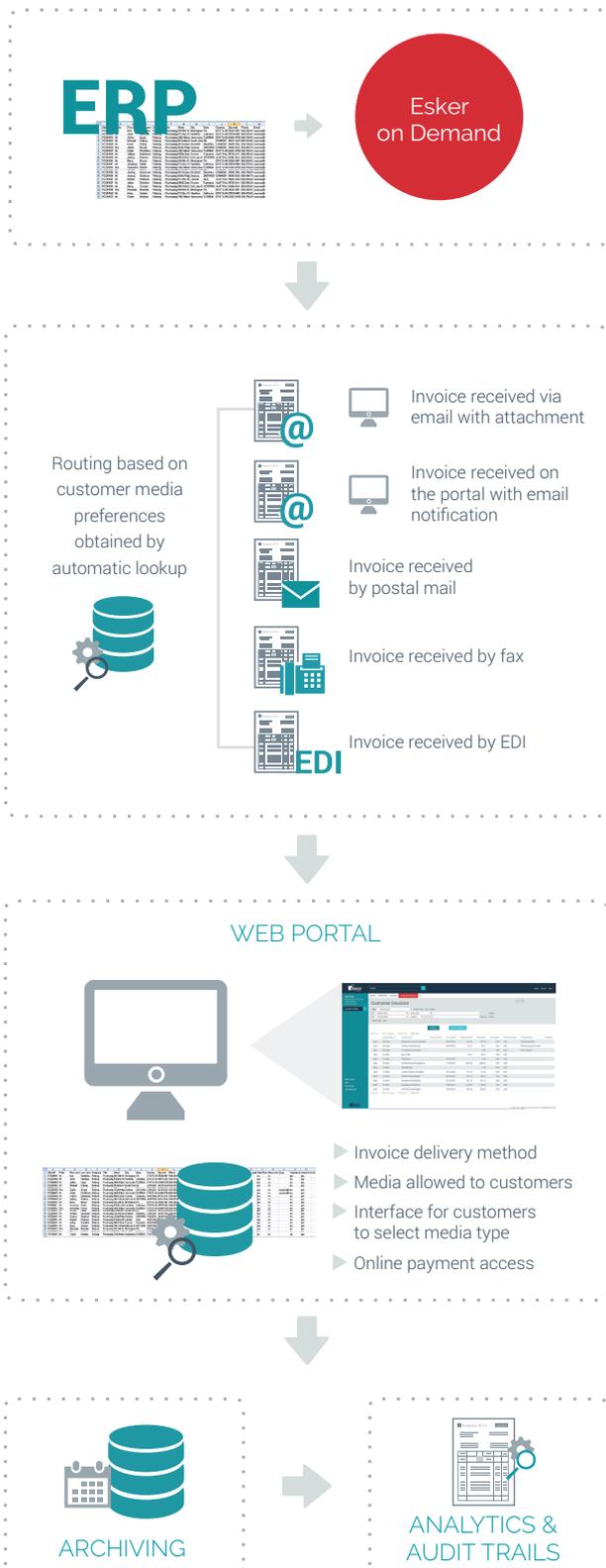


# CLOUD-BASED CUSTOMER INVOICE AUTOMATION

The solution is delivered as a cloud service for quick deployment and fast results, offering robust functionality in an affordable package.



## How the Esker Solution Works

**Documents are securely transmitted from your ERP to the Esker on Demand platform via the Esker Loader.**

- Document batches will contain one type of invoice in one format
- Additional formats and document types are available as add-ons

**Key information is extracted from the PDF. The customer number is extracted from the invoice and used to automatically look up delivery preference before invoice is delivered.**

- Delivery options include: mail, fax, EDI, email with attachment or publishing on the customer portal with notification via email

**The web portal is available for your customers to view invoices, payment status and pay invoices online.**

- Customised web portal with your logo
- Ability for you to populate and maintain your customers in the portal by CSV file imported via the Esker Loader
- All invoices can be published on the portal even if they are sent via another media
- Easily pay any open invoice online directly using a credit card, online transfer, PayPal, etc. Once paid, transaction payment details can be updated in the ERP or business application

**Encourage subscription to e-invoicing via the web portal.**

- Send customers portal login ID/password via email or postal mail
- Customers can select and change delivery preferences at any time from media you choose to make available

**Regulatory Compliance & Interoperability**

- E-invoices are processed and archived in compliance with all international regulations (e.g., e-signatures, EDI, sales order matching, tracking and reporting capabilities for business controls audit trails, e-archiving, etc.) to ensure regulatory compliance in over 40 countries
- All types of EDI formats (e.g., XML, EDIFACT, ANSI, UBL, etc.) can be generated and communicated to platforms from other service providers and public administrations
- Archiving for 2 months included at no charge, with options to extend archiving for up to 11 years

**Monitor invoice delivery with ready-made reports, packaged KPIs and optional custom reporting capabilities.**

- Esker dashboards provide every user with information needed to perform their daily tasks
- Reports can be run ad-hoc or automatically on a set schedule

## Training and Support

To give you a solid start, Esker provides training for end-users and administrators. In addition to testing sessions with users, Esker training is adapted to different user profiles and usages of the solution. This includes daily AR team use and administrative use, and in-depth knowledge on application features.

## Add-Ons

Beyond the base solution, you can choose from optional add-on features to meet specific requirements, each available for a flat fee:

- Additional document types
- Document formatting
- Setup for input formats other than PDF
- Invoice archiving for up to 11 years
- Invoices going to the same address during a given day will be grouped before delivery
- If invoices sent to the portal are not viewed in a given time frame, you may elect to send the invoice via postal mail
- Online payment
- Past-due reminders

## Accounts Receivable Challenges

Businesses are eager to save the cost of mailing invoices to customers. But many companies sacrifice e-invoicing benefits to satisfy customers who prefer to receive their invoices and other billing documents by postal mail. In addition, the inability to send billing documents as they are generated, and to immediately retrieve invoices, results in payment delays that inflate Days Sales Outstanding (DSO) rates.
